



PERSONAL DATA PROCESSING POLICY

1. One of the conditions for the activities of JSC FC LOKOMOTIV (hereinafter referred to as the «Operator») is to ensure the security of personal data.

2. The policy of processing personal data of JSC FC LOKOMOTIV determines the procedure for the collection, storage, transfer and processing of personal data.

3. By providing the Operator with his personal data when registering on the site <https://www.fclm.ru> (hereinafter referred to as the «Site») or when placing an order on the Site or posting information about himself on the Site, the individual agrees to their processing .

4. JSC FC LOKOMOTIV processes the following data:

- personal data of employees;
- personal data of individuals, including users of the Site, fans, buyers of goods / services (hereinafter referred to as «Users»).

5. Personal data is processed in accordance with the requirements of the Federal Law No. 152-FZ «On Personal Data» of 27.07.2006.

6. Upon registration, User provides:

- Full Name);
- E-mail address;
- Password;

When placing an order, User provides:

- Full name;
- Date of birth;
- address;
- Phone number and additional information;
- Other data if they are necessary for the performance of obligations.

The operator also processes technical information:

- Access time and IP address;
- Referral sources;
- Banner views;
- Other technical information provided by the browser.

Personal data may also include additional information provided. The operator has the right to request a copy of the identity document or other document containing the name, surname, photo, as well as additional data that, at the discretion of the Operator, will be necessary for identification and will eliminate abuse.



7. The operator (including with the involvement of third parties) uses the data provided for the purposes of registration / authorization on the Site, processing orders and fulfilling its obligations, evaluating the work of the Site, studying the market, researching statistical data on sales volumes and quality of services, , the organization of loyalty programs, promotion of services or products through electronic and sms-dispatches.

The operator can combine this information with another to provide and improve their products, services.

8. The user has the right to refuse receiving advertising information by sending a notice.

9. The operator has the right to perform the following actions with personal data: collection, recording, systematization, storage, clarification, extraction, use, transfer, depersonalization, blocking, deletion, destruction.

10. The User has the right:

10.1. To receive information regarding the processing of his personal data in accordance with the procedure established by Law No. 152-FZ «On Personal Data» of 27.07.2006.

10.2. Require clarification of their data, their blocking or destruction in the event that the data is obsolete, inaccurate or illegally obtained.

11. The user can withdraw consent to processing the data by sending a message to site@fclm.ru or by mail. Termination of data processing may be the basis for refusing to fulfill obligations to the User.

12. The validity of the consent to the processing and use of data: necessary for processing, but not less than 10 years from the

date of registration / authorization, or prior to the withdrawal of consent.

13. The operator has the right:

- Defend their interests in court;
- Provide data to third parties in cases provided for by these Regulations and legislation;
- Refuse to provide in cases stipulated by law;
- Use the personal data of the subject without his consent in cases stipulated by law.

14. Consent to registration / authorization on the Site and its use is consent to the Policy and is equivalent to a written agreement.

15. The operator undertakes not to disclose the information received from the User. It is not a violation of the provision of information to third parties acting in fulfillment of the Operator's obligations to the User. It is not a violation of the provision of information at the request of government agencies, in accordance with the requirements of the current legislation of the Russian Federation.

16. The operator is not liable for losses that the User may incur as a result of the fact that his login and password to the Site became known to third parties through no fault of the Operator.

17. The operator may amend the current provisions of the Policy, with the changes taking precedence over the provisions in force.
